DANGEROUS GOODS and PROHIBITED ARTICLES

As per Global Jet's safety policy in accordance with EASA Safety Guidelines, Damaged, defective or recalled lithium batteries shall not be carried onboard as they pose a significant safety risk (e.g Samsun Galaxy Note 7)

PED's containing lithium batteries carried by passengers should be carried in the passenger cabin, to enable the crew to react expeditiously in case an incident involving such a PED occurs.

Portable electronic devices which are carried in checked baggage shall be switched off all times

Prohibited baggage

In order to guarantee your safety the below items are considered Dangerous Goods, shall not be placed in hold or checked baggage and will not be carried by Global jet:

A. Electric Devices

- Security-type attaché cases, cash boxes, cash bags, etc.
- Briefcases and diplomat's cases with built in alarm devices.
- Primary non rechargeable lithium batteries and cells. Rechargeable batteries for mobile phones and laptops are exempted.
- Non-rechargeable lithium batteries and cells from 2 g lithium per battery
- Electric shock weapons (e.g. Tasers) with explosives, compressed gases or lithium batteries

B. Flammable and Explosive Materials

- Flammable solid items such as matches and other flammable and combustible materials
- Flammable, non -flammable, deep frozen and toxic propellants
- Lighter gas
- Camping gas
- Camping stove
- Combustible paste (e.g. for a fondue)
- Flammable liquids such as lacquers, thinners, petrol or solvents
- Flammable and non-flammable paints
- Objects that release flammable gases on contact with water.
- Explosives, ammunition, fireworks and signal rockets
- Combustion engines (e.g. lawnmower, powered saws)

C. Gases

- Irritant gases such as pepper spray, KO sprays etc.

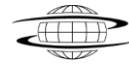

- Gas for lighters, camping stoves and burners
- Butane gas bottles
- Gas cylinders
- Blue flame lighters or cigarette lighters
- Carbon cartridges for mineral water preparation

D. Biohazard and Toxic

- Radioactive material
- Toxic and infectious substances (viruses, bacteria)
- Oxidizing substances such as bleach and peroxide
- Corrosive substances such as acids, mercury, alkaline and cell battery liquids

E. Other dangerous goods

- Magnetic objects and other substances that are classified as dangerous
- E-bikes
- Self-balancing electronic devices (e.g. hover boards , balance wheels)



The above provisions do not apply to medicines and medical appliances, toiletries, smoking utensils or alcoholic drinks, as long as these are carried only in small quantities for personal use.

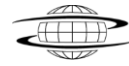

Prohibited items in checked baggage

Checked baggage must not contain;

- Fragile items
- Valuables including money
- Jewelry
- Precious metals
- Computers (including laptops, PED's and tablets)
- Cameras
- Mobile phones
- Electronic cigarettes
- Securities
- Stocks and bonds
- Business documents
- Samples
- Identification documents
- House or car keys
- Essential medicines and/or medical aids and appliances required by the passenger
- Spare lithium batteries
- Lithium ion battery-powered vehicles (including Segway's and hover boards) and lithium.

Global Jet may refuse to carry these items in checked baggage and is liable only for damage/loss that is willfully caused or caused by gross negligence.

Prohibited items in hand baggage:

A. **Guns, Firearms And Other Devices That Discharge Projectiles** (devices capable, or appearing capable, of being used to cause serious injury by discharging a projectile), including:

- Firearms of all types, such as pistols, revolvers, rifles, shotguns,
- Toy guns, replicas and imitation firearms capable of being mistaken for real weapons,
- Component parts of firearms, excluding telescopic sights,
- Compressed air and CO2 guns, such as pistols, pellet guns, rifles and ball bearing guns,
- Signal flare pistols and starter pistols,
- Bows, cross bows and arrows,
- Harpoon guns and spear guns,
- Slingshots and catapults;

B. **Stunning Devices** (devices designed specifically to stun or immobilize), including:

- Devices for shocking, such as stun guns, Tasers and stun batons,
- Animal stunners and animal killers,
- Disabling and incapacitating chemicals, gases and sprays, such as mace, pepper sprays, capsicum sprays, tear gas, acid sprays and animal repellent sprays;

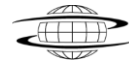

- C. **Objects With A Sharp Point Or Sharp Edge** (objects with a sharp point or sharp edge capable of being used to cause serious injury), including:
- Items designed for chopping, such as axes, hatchets and cleavers
 - Ice axes and ice picks,
 - Razor blades,
 - Box cutters,
 - Knives with blades of more than 6 cm,
 - Scissors with blades of more than 6 cm as measured from the fulcrum,
 - Martial arts equipment with a sharp point or sharp edge,
 - Swords and sabers;
- D. **Workmen's Tools** (tools capable of being used either to cause serious injury or to threaten the safety of aircraft), including:
- Crowbars,
 - Drills and drill bits, including cordless portable power drills,
 - Tools with a blade or a shaft of more than 6 cm capable of use as a weapon, such as screwdrivers and chisels,
 - Saws, including cordless portable power saws,
 - Blowtorches,
 - Bolt guns and nail guns;
- E. **Blunt Instruments** (objects capable of being used to cause serious injury when used to hit), including:
- baseball and softball bats,
 - clubs and batons, such as Billy clubs, blackjacks and night sticks,
 - martial arts equipment;
- F. **Explosives And Incendiary Substances And Devices** (explosives and incendiary substances and devices capable, or appearing capable, of being used to cause serious injury or to pose a threat to the safety of aircraft), including:
- Ammunition,
 - Blasting caps,
 - Detonators and fuses,
 - Replica or imitation explosive devices,
 - Mines, grenades and other explosive military stores,
 - Fireworks and other pyrotechnics,
 - Smoke-generating canisters and smoke-generating cartridges,
 - Dynamite, gunpowder and plastic explosives.

Restriction on liquids in hand baggage (EU Regulation 1546/2006)

The new European Commission regulation on Security in Civil Aviation restricts the amount of liquids that passengers are permitted to take on board an aircraft in their hand baggage.

Passengers may carry in their hand baggage liquids or comparable items of similar consistency only in small amounts and in small individual containers. It must be ensured that these liquids are in individual containers with a capacity of no more than one hundred (100) ml, or the equivalent amount given in a different unit of **measurement (as indicated by the maximum contents printed on the container – a half-full two hundred (200) ml container is not permissible)**. All of these individual containers must be packed in a transparent, re-sealable plastic bag with a capacity of no more than one (1) litre.

Only one plastic bag is allowed per person.

Liquids include:

Gels

Pastes

Lotions

Toothpaste

hair gels

soups

syrups

beverages

perfume

other items of similar consistency, as well as the contents of pressurised containers such as aerosols, shaving cream and hair spray
